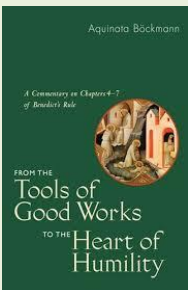

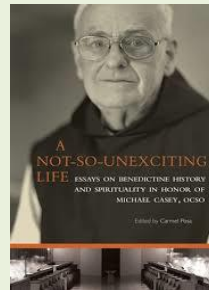

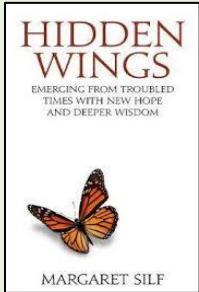
From the Tools of Good Works to the Heart of Humanity: A Commentary on Chapters 4-7 of Benedict's Rule (2017)

Aquinata Böckmann, a contemporary expert in interpreting the rule of St. Benedict, explores Chapters 4-7 of The

Rule and examines the Rule's spiritual wisdom of good works, obedience, silence and humility. Böckmann explains that after analyzing the text and sources, she considers the aim of Benedict's instruction and what it may say to us today. Close attention is paid to the omissions from Benedict's major source, the Rule of the Master, and to what he has added or changed, reasoning that this helps us to see Benedict's character more clearly and gain inspiration from that in our own life. This is the fourth volume of Aquinata Böckmann's commentaries on the Rule of St. Benedict.

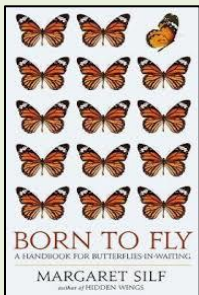


Hidden Wings: Emerging From Troubled Times With New Hope and Deeper Wisdom (2017)

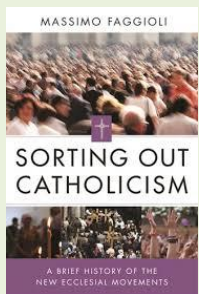


Born to Fly: A Handbook for Butterflies-in-Waiting (2017)

explore what it means to be an agent of spiritual change in our own life and that of the world around us. It includes a five-week Lenten study.

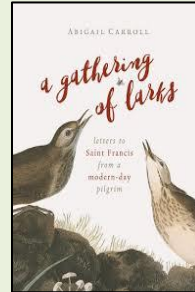


Sorting Out Catholicism: A Brief History of the New Ecclesial Movements (2014)

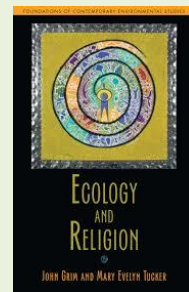


A Gathering of Larks: Letters to Saint Francis from a Modern-Day Pilgrim (2017)

Grim and Tucker maintain that the natural world has been central to all the world's religions, and that today's growing environmental challenges make the relationship ever more vital. They explain how religious teachings

The authors' describe four fundamental aspects of religious life: orienting, grounding, nurturing, and transforming, and reason that the engagement of religious communities is necessary if humanity is to sustain itself and the planet.



Evil: How our culture is going off the rails (2016)

This book is a guide for an up-to-date system of values. What once used to be deadly sins threatening human salvation have now become socially acceptable; envy, greed,

stubbornness, impatience, narcissism and disloyalty. Nokter Wolf has taken a look at an interesting development and finds examples in the Bible, in the ancient myths and current affairs. His conclusion: the deadly sins are as relevant today as ever before and it would be advisable not to leave the field open to them in our Western economic and social systems, but rather to counter them with a foundation of values that are up to date. Readers will recognise our day and age in the mirror of this book.
